Overview of Service

The VAT Reclaims Service enables users to prepare VAT Refund Claims in all European countries. In particular it enables users to:

- enter / upload invoice data that needs to be included in a claim
- review reports of information to be shown in each VAT Refund Claim
- prepare claims ready for submission (application forms and/or invoice lists for each claim)
- export claims in an Excel format
- prepare reports showing the financial status of each submitted Claim

Additional facilities are available, subject to additional fees

Key Features

- Unlimited Transactions: Users can prepare any number of claims for any number of companies, each with unlimited transactions
- Free Setup Facility: An easy to use guide helps you get set up in minutes
- Unlimited Users: You can authorise additional users in blocks of 5. Within each block, individual users can be added or changed each with varied accessibility to give you maximum control and flexibility
- **Ease of Input:** You can input invoices manually invoice by invoice or as a preprepared batch. This means that it can be used with virtually any accounts or employee/management expense package. There are also facilities to help with input, such as autocompleting of supplier data and automatic VAT coding
- **Bespoke Reporting:** To maximise control, the service enables reports to be tailored. It also provides an ongoing history of data used
- **Safety:** The structure of each Country's Claim is constantly updated to keep in line with each country's tax legislation. Free data validation tests help ensure that data that you send to us is safe to import
- **Export Submission:** All claims are exportable in Excel, but if you wish to export in an alternative format e.g. XML, CSV, PDF please ask us to quote. Submission can be made via our approved agents if you prefer

Getting Started

If you are already registered to use another euVAT service, your Principal user can simply add the Reclaims Licence to your organisation's existing package.

If you are not registered, your first step is to register for the Master Licence by visiting <u>https://register.euvat.org</u> and choosing the Reclaims Licence.

When you first register, you will be asked for basic contact details of the Licensee; this does not have to be the organisation for which claims are to be prepared.

Once registered, you as Licensee will be provided with a pro forma invoice. Once payment has been made, your account will be activated.
